**NOTICE OF VIRTUAL PUBLIC HEARING  
HOME-ARP DRAFT ALLOCATION PLAN**

Notice is hereby given that the City of Gary, Indiana will hold a Virtual Public Hearing on January 24, 2023 from 1:00 to 2:30 PM to discuss the HOME-ARP Draft Allocation Plan and to accept public feedback.

The City of Gary has the unique opportunity to address homelessness with federal HOME-ARP funds in the amount of \$2,490,094. The City may undertake the following range of activities based on community feedback and information from key stakeholders:

- Acquisition and Development of Non-Congregate Shelter/HOME-ARP Rental Housing Combination
- Supportive Services
- Non-Profit Operating and Capacity Building Assistance
- Administration and Planning

After seeking public input on the best way for the City to spend those dollars, the City is in its final stages of developing its Draft HOME-ARP Allocation Plan that will inform the public of the intended uses of the funding.
